You are hereby notified that the Informational Meeting and Annual Meeting of the voters of Union High School District #2 will be held in the Murray Auditorium at the Randolph Union High School in the Town of Randolph on Monday, February 1, 2016, commencing at 7:00 p.m.


NOTICE TO VOTERS: ARTICLES I, II, III, IV and V will be voted on the Floor.


Polls for voting on Articles VI, VII and VIII will be open on Tuesday, February 2, 2016 at the following locations and at the following times in each member district:

Braintree: Braintree Town Clerk's Office from 10:00 a.m. to 7:00 p.m.
Brookfield: Brookfield Town Clerk's Office from 8:30 a.m. to 7:00 p.m.
Randolph: Randolph Town Hall from 7:00 a.m. to 7:00 p.m.

- ARTICLE I: To elect a Moderator and a Clerk each for a one year term beginning July 1, 2016.
- ARTICLE II: To elect a School District Treasurer for a one year term beginning July 1, 2016.
- ARTICLE III: To fill any vacancies existing or occurring on February 1, 2016.
- ARTICLE IV: To hear and act upon the reports of the officers of the school district.
- ARTICLE V: To see whether the school district will authorize the School Board to borrow money pending receipt of payments from the member districts, by the issuance of notes or orders payable not later than one year from the date thereof.
- ARTICLE VI: To vote by Australian ballot on the following monetary item:
1. Shall the voters of the Randolph Union High School District #2 approve the transfer of \$41,518 in surplus funds from the 2014-2015 school year to the Building Maintenance Fund?
- ARTICLE VII: To vote by Australian ballot on the following monetary item:
1. Shall the voters of the Randolph Union High School District #2 approve the school board to expend \$8,137,469, which is the amount the school board has determined to be necessary for the ensuing fiscal year? This represents a -0.66% decrease from the previous year. It is estimated that this proposed budget, if approved, will result in education spending of \$14,611 per equalized pupil. This projected spending per equalized pupil is 1.54% higher than spending for the current year.
- ARTICLE VIII: To vote by Australian ballot on the following monetary item:
1. Shall the voters of the Randolph Union High School District #2 approve the school board to expend \$3,051,115 for the Randolph Technical Career Center, which is the amount the school board has determined to be necessary for the ensuing fiscal year? This represents a 0.42% increase from the previous year.




