

**BOARD OF CIVIL AUTHORITY MEETING MINUTES**  
**MAY 24, 2011**  
**RANDOLPH TOWN HALL, CONFERENCE ROOM B**

The meeting was called to order at 7:40 p.m. by Richard Burstein, board chair. The first order of business was to review the applications for addition to the voter checklist. While the applications were being circulated to the board members for review, Town Clerk Joyce Mazzucco handed each board member a copy of a list of names of voters who have not responded to challenge letters after two General Elections. According to 17 V.S.A. § 2150(5), these voters' names can now be removed from the voter checklist upon the approval of the Board of Civil Authority. A discussion followed about the names on the list and about the procedure for purging names from the checklist. Participating in the discussion were the following individuals: Barbara Angell, Joyce Mazzucco, Richard Burstein, Jack Cowdrey, Ruth Lutz and John Jackson. Ruth Lutz made a motion to purge the 145 voters' names from the voter checklist. The motion was seconded by Barbara Angell.
